Reminders:

- Review HEDIS™
- performance on Monthly Risk Reports via NaviNet.
- Use Category II codes to bill for BP and A1C results.
- Give EMR access to the Select Health's Quality Team to pull results/data.
- Upload clinical records directly through Appian.
- Contact your Provider Network Account Executive for questions and to schedule Quality meetings.

Review your monthly Healthcare Effectiveness Data and Information Set (HEDIS™) reports available in NaviNet. Ask your provider network account executive about monthly Quality meetings and data exchange.

SCDHHS Benefit Update Reminders The South Carolina Department of Health and Human Services (SCDHHS) added coverage for the following:

Effective October 1, 2024

- Lyfgenia, a one-time gene therapy to treat Sickle Cell Anemia.
- Psychiatric Collaborative Care Model (CoCM) services for full-benefit Healthy Connections Medicaid members.
- Intensive outpatient programs (IOPs) and partial hospitalization programs (PHPs) with a psychiatric focus for children and adults who are full-benefit Healthy Connections Medicaid members.



Effective December 1, 2024

The South Carolina Department of Disabilities and Special Needs (SC DDSN) has partnered with the South Carolina Department of Health and Human Services (SCDHHS), to offer a free training opportunity for Healthy Connections Medicaid providers interested in better understanding the special health care needs of people with intellectual and developmental disabilities (IDD). The training is titled "Curriculum in IDD Healthcare" and is produced by IntellectAbility. The cost of the training is being covered by DDSN. Foster Care

Reminders when Caring for Children and Youth in Foster Care

Initial Well-Visits Requirements:

- ✓ Required within 30 days of entering care (preferably within 7 days)
- ✓ Minimum of 2 well-visits per year based on age

Age Group Required Frequency

- ✓ Under 6 months
 - Monthly
- ✓ 6 months 24 months
 - Every 3 months
- ✓ Over 24 months 21 years
 - o Every 6 months

Important Notes:

- Use CPT 99358 with modifier UA for initial Foster Care visits
- A well and sick visit may be billed on the same date of service. The sick visit requires that a complaint or illness be recorded before a service is compensable and must be billed with modifier 25.

Psychotropic Medication Requirements:

- Informed consent and 'red flag staffing' are required for:
 - Children 6 and under receiving new psychotropic medication
 - o 4 or more psychotropic medications per regime
 - New antipsychotic medication prescriptions

Prior authorization – Current Procedural-Terminology (CPT) online lookup tool

You can easily determine if a service requires <u>prior authorization</u> by using the CPT lookup tool on our website. No need to call – using the CPT lookup tool is as easy as 1-2-3!

- 1. Enter a CPT/HCPCS code.
- 2. Click the submit button.
- 3. The tool will indicate if the service requires prior authorization as of the day queried.

How to join:

If your practice is contracted with First Choice Medicaid, and the providers are currently credentialed, simply request an amendment to your existing contract by contacting your provider network <u>account executive</u>.

NaviNet Provider Portal

The NaviNet provider portal is a valuable resource to help providers manage administrative functions including checking eligibility, reviewing HEDIS[™] and quality reports, verifying other insurance information, and submitting prior authorization requests.


